It is not going to do legal reasoning, not going to do case strategy. What it's supposed to do is do repeatable rote tasks much more quickly and efficiently," (Thomson Reuters, 2024) . The federal judge stated, "Technological advances are commonplace and there is nothing inherently improper about using a reliable artificial intelligence tool for assistance. But existing rules impose a gatekeeping role on attorneys to ensure the accuracy of their filings" (Neuemeister, 2023).

Validating findings or using trusted AI models is critical to maintain accuracy. Yet, if risks are assessed and AI properly sourced, the impact AI can have on efficiency is profound: faster document review, improved case preparation and excellent starting point materials for deeper analysis.

#### Cloud Computing

Cloud computing offers secure, scalable and accessible data storage solutions essential for modern law practices. These platforms facilitate seamless collaboration among team members, regardless of their location, through remote work and virtual meetings.
